NOTICE FOR AUCTION

Sealed quotations are invited by the undersigned only in Government of India Post for auction of dismantled old parts of 10 KW TV Transmitter make BEL Mark-III, rigid copper transmission lines etc. as per attached list & on 'AS IS WHERE IS BASIS'. All the materials notified for auction are properties of Govt. of India and are approved for auction by competent authority. The materials will be treated as scrap for the purpose of auction. Only firms who have valid GST registration and have filed Income Tax return for the Assessment year 2017-18 will be allowed to participate in the auction process. The bidders will produce proof of these documents attached with their quotation. The quotation must reach the undersigned by name by 3.00 P.M on 18-12-2017. The quotation will be opened in the office of the undersigned at 4.00 PM on 18-12-2017. The bidders may choose to be present at the time of opening or depute their legal representative with proofs of identity and authorization by the firms. The following documents will be submitted by the bidders attached in their quotations.

1. Proof of Identity either by Aadhar Card/PAN or any other Govt. documents having photograph.
2. Proof of business in scrap dealing
3. Income Tax assessment for Assessment year 2017-18
4. GST registration

The reserve price for the complete materials put up for auction is Rs.75,000/- including all applicable taxes like GST. Applicable GST is charged at 18% against HSN code-7204. For intrastate bidders CGST & SGST will be charged. For interstate bidders IGST will be charged at 18%.

No quotations below the reserve price will be considered for auction. The successful bidders offering maximum price for a category will be allowed to lift the materials after paying full amount and GST@18% only on the quoted value by CTS cheque/Bank Demand Draft, payable in favour of "DDO DDK Bhawanipatna". The successful bidders will have to lift the materials and transport them out of the premises of Doordarshan Kendra Bhawanipatna within 72 hours after issue of lifting order.
